
- 1. Over the past year, the SCNA board has spent time on the following:



My neighbor got a ticket for improperly parking too close to his driveway because there was a huge snow Bank caused by the plows. There have been cars parked on the street for months where homeless people were living, spewing garbage on the street and sidewalks, without ever getting a parking ticket. For several weeks there was a loaded log truck parked on the wrong side of the street. I called the City and asked them why this was allowed to happen and they said they had never seen the truck. Ridiculous.


Do you feel like you know how to bring issues or questions to the SCNA board? 77 responses

 - I really hate the city's residential parking program
 - Thank you for doing this work. Our neighbors don't agree on things- so you are in a difficult position. Thank you for staying there, in the middle. And not trying to take positions on things people don't agree on. If people don't agree, the neighborhood should shouldn't have an opinion.
 - I think it would be helpful for people to know how to engage with you. Some of us have been here for multiple years but don't quite feel connected or aware enough to get involved.
 - The neighborhood block party is great but I really don't approve of using public funds to throw ourselves a party. We are one of the most affluent neighborhoods in Olympia and can afford to buy our own burgers and rent chairs.
 - Thank you for your diligent efforts!
 - Thank you for communications and meeting minutes!
 - Maybe SCNA could echo the cities requests to keep drains clear in front of our homes.
 - Good work
 - The moderator of the comments during the recent debate about people putting give away items on street corners should not be moderating comments. That whole thing was absurd and filled my inbox unnecessarily.
 - Our part of town is plagued with loud low flying helicopters and planes. Can we challenge the port about flight paths?
 - Members of the SCNA have gotten increasingly aggressive, harassing residents outside their own homes for perceived parking infractions, harassing residents about remodel decisions made in their own home, recording their neighbors comings and goings, providing tours to city council members and pointing out which homeowners they believe should be discriminated against (picked up on ring cameras btw very creepy!). It feels very gestapo. It's very disturbing you spend your time on this and makes me not want to be part of this group.
 - Please stop attempting to promote discrimination in housing ownership.
 - This neighborhood has a serious off leash dog problem. Dogs are required by law to be on leash everywhere with the exception of designated dog parks. Neighbors regularly release their dogs at Stevens field, Lincoln elementary, and even on the street. This is both criminal and simply disrespectful to people with children, people with other dogs, and people who are generally wary of dogs.

How are we supposed to be an actual community if we can't trust our neighbors to do the simplest things, like leashing their dogs? This is low hanging fruit for the scna board to tackle via neighborhood outreach, law enforcement, and creating new dog parks.

- I hope the city's plan to redesign Capital Blvd doesn't make it hard for s cap residents to use the street. I don't have much confidence in city traffic planners.
- I appreciate the dedication of the SCNA Board Members. It was very clear a
 great deal of time was spent researching and developing the response to the City
 regarding private businesses and other issues. Thank you for protecting each
 and every home owner. I am truly grateful.
- I know many of the homeowners in the neighborhood who work at the capitol. and I believe the Association would be better served by positively encouraging these homeowners to participate in the community rather than trying to push them out. Generally these people do a good job caring for their homes and are quiet. It is true that many of them aren't present year round, but part of the reason they aren't visible is because they feel like they need to keep their heads down to avoid the ire of some of their neighbors. If they were welcomed, assured that engaging wouldn't result in them being targeted, and asked to help with association initiatives I am confident they would slowly begin to engage and become an even greater asset to the community. The blunt reality is that there's a lack of property near the Capitol that is available for office use. The city and state haven't planned to accommodate the demand that is created by the fact that the Capitol campus is bounded by the lake, state buildings, and residential houses on three sides, and that for the most part the nearest commercially available property is simply too far away to be practical for most people who work on campus. There is a way to make sure the South Capitol neighborhood continues to be beautiful and retains its historic charm, but also adapts to the hard truth of its location and zoning realities.
- Bike lanes on Capital
- I am both a homeowner, raising my family in the neighborhood, and a business owner working from my home year-round. I would be deeply concerned about any position the SCNA might take that interfered with my ability to continue conducting my business from my home office. The modern economy allows a lot of people to work from home--we should not take any positions that would impose additional costs or restrictions on people working from home unless there's a clear adverse impact on neighbors.
